



# WINNIPEG WOMEN'S VOLLEYBALL LEAGUE

## INSURANCE CLAIMS

All registered players in the Winnipeg Women's Volleyball League (WWVL) are eligible for additional benefits and coverage as part of our SRIM Accident Coverage.

## REGISTRATION

To ensure that you and your team are properly covered, please make sure that your team contact has your current contact information listed on the WWVL registration system prior to your first match or when a change of address has occurred. All team members are required to sign a waiver, which can be signed at your first match of the season.

## MATCH

During a match, if a player goes down, regardless of the severity, the injury should be listed on the back of the scoresheet. This should be indicated by the referee. If the referee fails to mark down that a player was injured, either team can make a note on the scoresheet. It would be greatly appreciated if a witness ("player") marks down the injury report, not the injured player. Your tier convenor may need to reference this injury report if a claim will be made at a later date.

## MAKING A CLAIM

If the injury requires medical attention, please consider submitting a claim. This can be done by submitting an Incident Form, found at <https://www.wvvl.ca/insurance/srimclaimform.pdf>. Please fill out all of the information required and submit to our Insurance Liaison at [secretary@wvvl.ca](mailto:secretary@wvvl.ca). The Executive will confirm the injury on the scoresheet and forward to our Insurance Broker.

## FINALIZE YOUR CLAIM

A member of SRIM will be in contact with the player directly to gather any receipt or medical paperwork. This process can sometimes take up to 6 weeks. If SRIM has not been in contact within that 6 week timeframe, please contact [secretary@wvvl.ca](mailto:secretary@wvvl.ca) and they will follow up.

## FINAL NOTES

Due to the fact that this process can be lengthy and medical costs can accumulate quickly, if you believe that your injury is significant, please fill out the paper work and get the process started. You can always retract your claim. There is a one year time limit to file a claim, however always best to do within 30 days.
